In order for any learning environment to be successful, it must implement certain rules and boundaries. Below is a list of guidelines that will ensure a productive, peaceful and positive experience for all students and staff at My Oasis.

Students as well as their parents/carers are asked to read this form carefully and sign to acknowledge that they have understood the agreements.

## Student Expectations:

1. I will attend the school day on time.

2. I will sign in and out of the building when I enter and leave.

3. I will follow instructions or directions the first time they are given.

4. I will not bring food or beverages into the learning environments unless it has been agreed for me to do so.

5. I will tidy up my area before I leave the room.

6. I will be honest and report any damages that I have made or noticed.

7. I will not use electronic devices during class time or misuse or abuse them in any way. I will hand these over to staff or put them in the designated box within the classroom.

8. I will keep my hands to myself, and not touch other people or their belongings.

9. I will not be rude or disrespectful to other students, staff members, or any visitors who may visit the provision. I will treat everyone with respect.

10. I will come to class prepared with all of the necessary materials.

11. I will raise my hand to be recognised before speaking, not speaking over other students when they are talking.

12. I will conduct myself in a way that's safe for me, my classmates, and the teacher. I will not throw things or run around in the classroom.

13. I will not leave the learning environment/classroom or building without a staff member's permission.

14. When attending trips or off-site activities I will represent My Oasis in a positive manner.

15. I will NOT use homophobic, racist, sexualised or misogynistic language at any time.

16. I will take responsibility for my personal belongings and respect other people's property.

17. I will dress appropriately and WILL NOT wear any suggestive clothing including skinny tank tops, midriffs, short-shorts, or mini-skirts. I understand that I may be sent home for the day if I am wearing inappropriate clothing for any activities being undertaken
18. I will refrain from wearing clothes which have any signs of gang affiliation (e.g. scarves, bandanas) and refrain from using gang signs, calls, chants, movements and handshakes.
19. I will refrain from bringing weapons, illegal drugs, controlled substances and alcohol to school.

## CONSEQUENCES FOR NOT COMPLYING WITH THIS CONTRACT

**First Offense:** Warning

**Second Offense:** Parents/Carers and a student's mainstream school will be contacted by phone or in person.

**Third Offense:** Exclusion  
(The number of days will depend on circumstances.)

**Fourth and Subsequent Offenses:** Place at My Oasis is revoked.
